### Club Indemnity

To the fullest extent permitted under Pennsylvania law, the boat or camping trailer owner for themselves, guests, invitees, employees, agents, heirs and assigns hereby agrees to indemnify, defend, and hold the Susquehanna Yacht Club ("The Club"), its Flag Officers and Board Members harmless from:

1. Any and all liability for loss or damage to their boat, boat trailer, camping trailer, gear, equipment and contents for any reason, including The Club's equipment failure or acts of nature; and
2. Any and all loss, damage, liability, legal action or claim of any nature arising out of the boat or camping trailer owner's use of The Club facilities or The Club property; and
3. In the event of any damage or injury to The Club facilities or property arising from active or passive acts, omissions or negligence of the boat or camping trailer owner, all expenses incurred by The Club to repair or restore The Club facilities or property shall be paid by the boat or camping trailer owner who caused the damage.
